Venteicher moved and Lienemann seconded a motion the board reviewed the district's Title I parent involvement policy. A hearing was held asking for public comment, no one spoke at this time. Voting unanimous, motion carried.

Venteicher moved and Flesner seconded a motion that the board reviewed the district's wellness policy. Voting unanimous, motion carried.

Lienemann moved and Venteicher seconded a motion to accept the yearly policy update from legal council. Voting unanimous, motion carried.

Hoffmann moved and Lienemann seconded a motion to adjourn. Voting unanimous, motion carried. Meeting adjourned at 7:33 p.m.
